



Required Landlord Insurance Policy Information

Our Property Management Agreement requires that our Landlord clients will keep in force a Landlord insurance policy with at least \$ 1 Million in Liability. In addition, the Landlord insurance policy will name the Property Manager – Foundation Rentals and Relocation, Inc - as an **Additional Insured**, not Additional Interest. The owner must provide the Property Manager with a copy of the Landlord Policy DEC page showing the Property Manager Additional Insured Endorsement. If we do not receive this policy, we cannot continue to manage your property.

An Umbrella Policy or Excess Liability policy will not erase this requirement to be named as Additional Insured.

(Why is this coverage important: In the event we are named in a legal action regarding a claim on the property, we would have to incur legal costs which we would pass on to you since our management agreement provides indemnification, by being named as an Additional Insured on the property we manage, you would not have to pay our legal defense cost's. Most legal cost's require a retainer of \$5,000 or more)

If your current Landlord/Dwelling fire policy will not name us as Additional Insured, we have an A-rated carrier that will name us and we can refer you to a California NARPM Landlord insurance agent. You will even receive a discount on the new policy by having a Professional Property manager. Please see the attached filer. In addition, the new carrier can provide coverage's in the areas of:

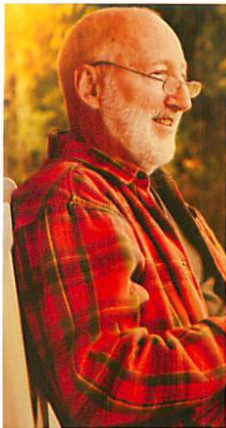
